Mtrs., and stated that, already obtained NOC for Occupancy from this Department vide reference 1st cited and also obtained Renewal NOC from this Department vide reference 2nd cited on the name of International Delhi Public School, Tadepalligudem.

3) Where as now the management is requested to issued Revised NOC on the name of International Delhi EM High School instead of International Delhi Public School.

4) It is suggested to the Management for providing the following Fire Safety Measures keeping in view of practicality, maintenance and resilience:

5) The Management has stated that, they satisfied with the installations and maintenance of the fire safety equipment working condition in the Educational building and also they declared that no additions or alterations have been made in the building affecting Fire Prevention and Fire Safety Measures including means of escape and that all exits and passages are free from any obstruction.

6) In view of the above, based on the self certification submitted by the Management and also taking into consideration of the larger public interest and in the context of the COVID-19 pandemic across the country, the Revised No Objection Certificate for Occupancy is issued to the existing building of M/s International Delhi EM High School, located at Telikicherla Road, Prakasa Rao Palem (V), Nallajarla (M), West Godavari District with Ground + (02) Upper floors with a height of 9.8 Mtrs., total built up area of 4903.08 Sq.Mtrs., for Educational Occupancy subject to the condition that the management to provide deficit Fire Safety system within one year and report compliance to this office without fail,

- 7) The Management shall ensure the following conditions:
- (i) The Management is responsible for all risks involved in case of Fire Accident.
 - (ii) This NOC is given based on the information, documents and drawings provided by the applicant. The applicant confirms that the information provided and the documents and drawings submitted are correct. Any deviation noticed will lead to cancellation of NOC without any notice.
 - (iii) The permission accorded does not confer any ownership rights. If it is found that the information furnished is false and fabricated, the permission will be revoked at any stage and the applicant will be liable for criminal prosecution as per IPC.

8) It is informed that, the Management is requested to maintain the following conditions compulsorily for safety purpose.



If not, take all steps to isolate the area by closing doors and windows.

9) This Revised No Objection Certificate for Occupancy is valid for a period of Five years from the date of issue of this letter subject to the compliance of above Fire and Electrical Safety Measures. The Owner/Occupier/Builder/Management concerned of the Building shall submit Self Declaration / Certification with regard to working condition of above Fire Safety System every year in the prescribed format and submit/upload the photographs of the Mock Drills conducted in the premises. It is the responsibility of the Builder to maintain the Fire Safety Equipment in good working condition at all times and apply for next Periodical Renewal of No Objection Certificate, duly remitting the User Charges vide G.O.Ms.No.90, Home (Prisons & Fire Services) Department Dated:13.08.2021 & G.O.Ms.No.120, Home (Prisons & Fire Services) Department Dated:25.10.2021, two (02) months before expiry of this of No Objection Certificate.

10) The No Objection Certificate for Occupancy & Renewal of No Objection Certificated issued vide references 1st & 2nd cited are hereby cancelled.

11) This Revised No Objection Certificate is issued, subject to the outcome of O.As/W.Ps etc., if any, bcforc Courts etc.,


